- Calling newspaper with ad (ad cost will be billed to the owner separately)
- Taking calls and showing apartment
- Complete screening and credit check of applicants for owner (member of the credit bureau of Columbus)
- Preparing lease paper work (in triplicate office-owner-tenant) keys made, and move in-move out check list.
- Eviction filing with the district court in your area and court appearance. This service is only performed with tenants that we pre-screened for the owner and filing is done within one year of original lease signing. For pre-existing tenants or term longer than 1 year the charge is \$150 per filing with district court, and another \$150.00 for the filing of order of possession plus court cost.

 \$25 fee for taking billing from vendors (n/a if vendor bills client direct)
